Councillor Mr Fox reported on the road at Poplars Corner/Broad Lane and the road has fallen away into the ditch/dyke area. Making this part of the road dangerous to drive on. Councillor White said he would look into this.

- Councillor Mr Fox requested if DMBC could install a power point on the lamp post near The Green to power the lights for the Christmas tree each year. Councillor White said he would look into this. The Parish Council are in agreement to pay any costs involved.
- Councillor Mrs Lifsey Reported on the new horse signs on the footpath. These are not very clear whether horses can or cannot go on the footpath. Ben said he would look into this. – No reply has been received.
- Councillor Mr Duckitt reported on the potholes on Wormley Hill Road to Ivy House Farm/Cowick Road. These are getting worse and urgently need repairing.
- Styles on the footpath along the Sykehouse Barrier Bank are in need of repairs. Agreed to contact Environment Agency
- Councillor Mr Fox reported he had cut the hedge on The Green.


