- Various branches on the tree on Chapel Lane are hitting overhead cables. This tree is due to be taken down as soon as the power is cut. Councillor White to contact DMBC for update
- Bins requested on Bridge House/Kirk Lane and Bate Lane/Chapel Lane Junction. These are to be installed on 25<sup>th</sup> September 2019
- Signs on the laybys and passing places stolen on Wormley Hill Road. 2 signs ordered have been fitted. 2 other signs are in the Parish of Fishlake.
- Councillor Mr Fox requested if DMBC could install a power point on the lamp post near The Green to power the lights for the Christmas tree each year. Councillor White to chase up and contact Councillor Fox
- Councillor Mr Fox reported on the road at Poplars Corner/Broad Lane and the road has fallen away into the ditch/dyke area. Making this part of the road dangerous to drive on. Clerk to contact Danvm Drainage
- Councillor Mr Duckitt requested lights for Wormley Hill in the new financial year. 2 posts could have lights erected on them. Site survey quote is £1,500 for 2 lamp brackets. Agreed to contact residents if they require lights near their properties
- 'Granby' on North Lane. Various buildings have been erected without permission and double skins around the current property. *No reply from DMBC.* Councillor White to chase again
- Speed sign data has been downloaded and will be circulated.
- Mattresses and rubbish have been dumped on Mawson Green Lane.
- Dykes have been cleaned out on Rudgate Lane, but the rubbish is left on the road. Clerk to contact Danvm Drainage
